Fabyan Parkway over the Fox River Project Description/Scope of Services:

This project consists of Phase I and Phase II type engineering design services for the rehabilitation of the Fabyan Parkway bridge over the Fox River in the city of Batavia, the oldest city in Kane County. The project will be designed and constructed with local funds. The services include:

- Detailed topographic surveys
- Inspections of existing bridge deficiencies including an infrared thermographic survey identifying areas of delamination and debonding
- Analysis and summary of recommended repairs with associated costs
- Engineering design for the selected repairs likely including:
 - o replacement wearing surface
 - o areas of full depth repair
 - o joint repair
 - o steel repair
 - o median replacement
- Maintenance of traffic plan
- Application and acquisition of permits from regulatory agencies as required by the scope of improvements
