Project Description

This work will primarily consist of determining and then leading our agency through all of the various activities required to successfully implement a new toll bridge facility. The Longmeadow Parkway Toll Bridge is anticipated to go-live in early 2022. These services will likely be a combination of on-call toll bridge operations support services, along with the development and completion of known tasks, such as:

- Development of comprehensive implementation schedule
- Development of Toll Collection System (TCS) and Back-Office System (BOS) policies and business rules

- Development of administrative rules for license plate tolling
- Assist with negotiating and developing an agreement with an E-ZPass Agency for I-Pass/E-ZPass transaction processing
- Prepare Request For Proposals for development, construction and maintenance of all-electronic TCS
- Prepare Request For Proposals for third-party video toll processing and collections services
- Assist in preparation of advertisement for Toll Collection Financial Analyst services
- Tolling Implementation and Operations Support Oversight of TCS, BOS and video toll processing and collections implementation activities
- Other tasks as assigned.
